WHEREAS, A copy of Amendment No. 1 is on file with the Clerk of the Board of Supervisors in File No. 180208, which is hereby declared to be a part of this resolution as if set forth fully herein; now, therefore be it

RESOLVED, That the Board of Supervisors hereby retroactively approves Amendment No. 1 to the Domestic Terminal Food and Beverage Program Lease No. 03-0204 with Bay Area Restaurant Group, JV; and, be it
