RESOLVED, That the Board of Supervisors hereby retroactively approves Amendment No. 1 to the Domestic Terminal Food and Beverage Program Lease No. 03-0196 to Lady Luck, LLC, copies of which are contained in Board of Supervisors' File No. 180421; and, be it
