

1 [San Francisco Police Department Insignia - Use for Ant-Man Film]

3 **Resolution approving the use of the San Francisco Police Department insignia for the**
4 **film, Ant-Man 3: Ant-Man and the Wasp: Quantumania.**

6 WHEREAS, The production company Pym Particles Productions III, LLC (the
7 “Producer”) is filming the motion picture, Ant-Man 3: Ant-Man and the Wasp: Quantumania
8 (the “Film”) in San Francisco; and

9 WHEREAS, The Producer will enter into a Use Agreement for City Property for Film
10 Production and Related Activities (“Agreement”) with the Film Commission; and

11 WHEREAS, A draft of the Agreement, in substantially final form, is on file with the Clerk
12 of the Board of Supervisors in File No. 210694; and

13 WHEREAS, The Producer would like to use the San Francisco Police Department
14 (“SFPD”) insignia in the Film and for marketing, advertising and promotion of the Film; and

15 WHEREAS, The Film is an all-union production, in alignment with San Francisco’s
16 labor harmony principals, utilizing members of the Directors Guild of America (DGA), the
17 Screen Actors Guild (SAG), and the International Alliance of Theatrical State Employees
18 (IATSE) Local 16; and

19 WHEREAS, The Film Commission passed a Resolution supporting the use of the
20 SFPD insignia for the Film to help the film with its authenticity, to help bring money and local
21 union jobs to the City, and to enhance San Francisco’s image as a premier film location site;
22 and

23 WHEREAS, The Board of Supervisors finds that the use of the SFPD insignia for the
24 Film will help bring money and an estimated 150 union jobs to San Francisco, will enhance

1 San Francisco's image as a premier location for film and television productions and is in the
2 best interests of the City; and

3 WHEREAS, Section 1.101 of the Charter provides that all rights and powers of the City
4 not vested in another officer or entity shall by exercised by the Board of Supervisors, and the
5 Charter does not vest in the SFPD the authority to agree to the use of its insignia in
6 connection with a commercial film production; now, therefore, be it

7 RESOLVED, That the Board of Supervisors hereby authorizes the Chief of Police to
8 agree to let the Producer use the SFPD insignia and other images of SFPD equipment and
9 resources in the Film and for marketing, advertising and promotion of the Film on terms
10 reasonably consistent with the draft Agreement; and, be it

11 FURTHER RESOLVED, That the SFPD insignia shall be used only for the stated
12 purposes, and shall not be used beyond the designations and purposes approved by this
13 Resolution; and, be it

14 FURTHER RESOLVED, That within 30 days of Agreement being fully executed by all
15 parties, the Film Commission shall provide it to the Clerk of the Board for inclusion in the
16 official file.
