[Supporting California State Proposition 67 - Referendum to Support Ban on Single-Use Plastic Bags]

Resolution supporting California's Proposition 67, which would uphold legislation banning single-use plastic bags.

WHEREAS, California's Plastic Bag Ban Referendum will appear as Proposition 67 on the November 2016 ballot, in which a "yes" vote will be in favor of upholding SB270, the plastic bag ban and a "no" will be in favor of overturning SB 270; and

WHEREAS, Each year California uses more than 13 billion single-use plastic bags, with 950 million plastic bags ending up as litter in landfills and in our neighborhoods, or as a danger to marine wildlife; and

WHEREAS, Plastic bags are a major source of litter and pollution in California, costing taxpayers an estimated \$34,000,000 to \$107,000,000 annually to manage plastic bag litter throughout the state; and

WHEREAS, According to the California State Department of Recycling, only 5% of single-use plastic bags are recycled; and

WHEREAS, According to a US Marine Debris Monitoring Program Study, plastic bags remain one of the top items found consistently during beach cleanups; and

WHEREAS, Single-use plastic bags create litter problems in streets, waterfronts, sewer systems clog storm drains; and

WHEREAS, The City and County of San Francisco has adopted citywide goals of 75% landfill diversion by 2010 and zero waste by 2020; and

WHEREAS, San Francisco became the first city in the nation to adopt a ban on plastic shopping bags in April 2007; and

WHEREAS, In February of 2012, the Board of Supervisors voted to expand the ordinance to all retail stores and food establishments and add a ten cent charge on bags at checkout; and

WHEREAS, Single-use plastic bag bans and charging for any store provided checkout bags promote a culture-shift among consumers to utilize reusable bags;

WHEREAS, 150 California cities and counties, including San Francisco, already have banned single-use plastic grocery bags independent of the state law representing over one-third of the state's population; and

WHEREAS, Proposition 67 would continue California's success in phasing out plastic bags, keeping in place a law passed by the legislature and signed by the Governor; now, therefore, be it

RESOLVED, That the Board of Supervisors of the City and County of San Francisco formally supports Prop 67, the Plastic Bag Ban Referendum.
