WHEREAS, On January 19, 2016, by Resolution No. 16-0017, the Airport Commission awarded the International Terminal Food and Beverage Concession Lease No. 16-0017 ("Lease"), to SSP America, Inc. for the operation of a 1300 on Fillmore restaurant in the International Terminal at San Francisco International Airport (the "Airport"); and

WHEREAS, This Board of Supervisors approved the Lease by Resolution No. 299-16 adopted on July 19, 2016; and

WHEREAS, In order to improve the guest experience at the new restaurant, the Airport and SSP America, Inc. desire to expand the lease premises; and

WHEREAS, On November 22, 2016, by Resolution No. 16-0303, the Airport Commission approved Amendment No. 1 to the Lease to effectuate the desired expansion of the lease premises, and to increase the annual guaranteed rent and annual promotional charge in proportion to the increase in square footage; now, therefore, be it

RESOLVED, That this Board of Supervisors retroactively approves Amendment No. 1 to the Lease, which (1) increases the square footage of the lease premises from approximately 1,694 square feet to approximately 2,100 square feet, and (2) increases the current annual guaranteed rent to \$279,000.00 and the annual promotional charge to

\$2,100.00, both in proportion to the increase in square footage of the lease premises; and, be it

FURTHER RESOLVED, That within thirty (30) days of the amendment being fully executed by all parties, the Airport Commission shall provide the final amendment to the Clerk of the Board for inclusion into the official file.
