

1 [Extending Time for Negotiations]

2 **Motion extending time for negotiations pursuant to Charter Section 11.100**

3 WHEREAS, the City and the Unions have been meeting and conferring over negotiable  
4 terms and conditions of employment to take effect July 1, 2001; and

5 WHEREAS, in order to be included in the budget to take effect July 1, 2001 an  
6 agreement or arbitration award must be adopted by ordinance within timelines set forth in  
7 Charter Section A8.409-4, as may be extended by Charter Section 11.100; and

8 WHEREAS, the Board of Supervisors previously extended in such deadlines in  
9 Resolution No. 91-97; and

10 WHEREAS, under Charter Section A8.409-4 the Human Resources Director has  
11 requested that the Board of Supervisors take action pursuant to Charter Section 11.100 to  
12 extend by thirty days the date for final adoption of ordinances approving such salary and  
13 benefits,

14 IT IS MOVED THAT, the date for final adoption of ordinances approving salary,  
15 benefits, and/or working conditions to be effective July 1, 2001 is hereby extended by thirty  
16 days. For Unions in negotiation which impasse has not been declared, the date for final  
17 adoption of ordinances approving salary, benefits, and/or working conditions to be effective  
18 July 1, 2001 is May 2, 2001. Such proposed collective bargaining agreements must be  
19 submitted to the Clerk of the Board no later than March 28<sup>th</sup>, 2001 in a form that will allow for  
20 complete review and costing.

21 BE IT FURTHER RESOLVED THAT, Arbitration panel awards issued pursuant to  
22 Charter Section A8.409-3 shall be submitted to the Clerk of the Board no later than May 30<sup>th</sup>,  
23 2001 in a form that will allow for complete review and costing.
