15 hearings on appeals for 3:00 p.m. The Clerk of the Board shall schedule consideration of  
16 ballot arguments and other election related matters when action is needed by the following  
17 day for 2:00 p.m. ~~Except for The recognition of visiting dignitaries which may occur at 2:00 p.m.~~  
18 may occur at anytime. The recognition of commendations shall occur at ~~3:00 p.m~~ 3:30 p.m. These  
19 recognitions of commendations should require no more than five minutes per recognition. No other  
20 fixed time for consideration of an agenda item shall be placed on the agenda except as  
21 directed by the President, or by affirmative vote of six Supervisors.
