13 Pages 36-39, San Francisco City and County Records and a portion of the real property
14 described in Book 3989, at Page 397, Official Records of the City and County of San
15 Francisco," comprising 8 sheets, approved December 3, 2010 by Department of Public Works
16 Order No. 179,008 together with the Public Improvement Agreement dated December 8, 2010
17 by and between Hunters Point Affordable Housing, Inc., a California nonprofit public benefit
18 corporation, and the City and County of San Francisco (City) are hereby approved and said
19 map is adopted as an Official Final Map of the Hunters View for Assessor's Block 4624, Lots
20 3, 4, and 9, and Assessor's Block 4720, Lot 27; A copy of said Public Improvement
21 Agreement is on file with the Clerk of the Board in File No. 101501 and is incorporated herein
22 by reference; and be it


23 FURTHER MOVED, That the San Francisco Board of Supervisors adopts as its own

5 FURTHER MOVED, That the San Francisco Board of Supervisors hereby authorizes
6 the Director of the Department of Public Works to enter all necessary recording information on
7 the Final Map and authorizes the Clerk of the Board of Supervisors to execute the Clerks
8 statement as set forth herein; and be it

9 FURTHER MOVED, That approval of this map is also conditioned upon compliance by
10 the subdivider with all applicable provisions of the San Francisco Subdivision Code and
11 amendments thereto.
