AMENDING CHAPTER 16 OF PART I OF THE SAN FRANCISCO MUNICIPAL CODE (ADMINISTRATIVE CODE), BY AMENDING SECTIONS 16.900, 16.902, 16.903, 16.904, AND 16.905, TO UPDATE PROVISIONS DEALING WITH EMPLOYEE BENEFIT CAFETERIA PLANS.

Note: Additions are underlined; deletions are in ((double parentheses)).

Be it ordained by the People of the City and County of San Francisco:

Section 1. Chapter 16 of the San Francisco Administrative Code is hereby amended by amending Section 16.900, to read as follows:

#### SEC. 16.900. ESTABLISHMENT OF A CAFETERIA PLAN.

[Administrative Code Revisions, Chapter 16, Article XVII]

The <u>Department of Human Resources</u> ((Health Service Board)) may establish an employee cafeteria plan as provided and regulated under Section 125 of Title 26 of the United States Internal Revenue Code.

Section 2. Chapter 16 of the San Francisco Administrative Code is hereby amended by amending Section 16.902, to read as follows:

# SEC. 16.902. ADMINISTRATION BY THE <u>DEPARTMENT OF HUMAN RESOURCES</u> ((HEALTH SERVICE BOARD)).

The cafeteria plan established pursuant to this Article may be administered by the <u>Department of Human Resources</u> ((Health Service Board)) which may prescribe such forms, and adopt such rules and regulations as are necessary to carry out the purposes of the plan. The <u>Department of Human Resources</u> ((Health Service Board)) may contract with a financially responsible independent contractor to administer and coordinate the plan.

Section 3. Chapter 16 of the San Francisco Administrative Code is hereby amended by amending Section 16.903, to read as follows:

#### SEC. 16.903. NO COST TO CITY AND COUNTY.

((The Health Service Board may request the City and County of San Francisco to advance funds to finance start-up costs to implement the cafeteria plan. The Board of Supervisors will consider such an advance provided that the Health Service Board demonstrates that these start-up costs will be recovered by the City through a reduction in the City's Federal Insurance Contributions Act tax obligations. Thereafter, except as provided in San Francisco Charter Section 8.423, this)) This cafeteria plan shall be administered free of direct cost to, or appropriation by, the City and County of San Francisco. Except as herein provided, all such costs shall be borne by the participants or by any plan administrator appointed hereunder, except to the extent that any subsequent ordinance or appropriation might provide expressly to the contrary. Nothing contained in this Section shall be deemed to prohibit the inclusion of a hold harmless provision in any contract between the City and any plan administrator appointed hereunder, which provision has been approved by the City's Risk Manager pursuant to Administrative Code Section 1.24.

Section 4. Chapter 16 of the San Francisco Administrative Code is hereby amended by amending Section 16.904, to read as follows:

#### SEC. 16.904. VOLUNTARY EMPLOYEE BENEFITS.

((The adoption of voluntary employee-sponsored benefits, to be offered only as benefits in the employee cafeteria plan as provided and regulated under Section 125 of Title

26 of the United States Code ("Section 125"), consisting of those plans which have been adopted by the Health Service Board and approved by the Board of Supervisors and which are on file with the Clerk of the Board of Supervisors. The cost of the premiums, administrative fees and reimbursement amounts of the employee-sponsored benefits set forth in this Section shall be borne entirely by the employee with no employer contribution. However, Section 16.903 notwithstanding, the City agrees to undertake obligations for contingent liabilities as set forth in Sections II.E and VI of the services agreement with Benefit America.)) Based upon individual authorized deductions, the Controller is hereby authorized to deduct and collect monies from the salaries or wages of employees of the City and County of San Francisco and the San Francisco Community College District in accordance with San Francisco Administrative Code Sections 16.91 and 16.92. Pursuant to Section 125, this voluntary authorized deduction shall not be revocable by the employee during the cafeteria plan year unless the revocation and new election are in conformance with Section 125 and the terms of the plan. ((This Section shall be effective upon implementation of the employee cafeteria plan by the Health Service Board.))

Section 5. Chapter 16 of the San Francisco Administrative Code is hereby amended by amending Section 16.905, to read as follows:

#### SEC. 16.905. CAFETERIA PLAN BENEFITS.

The Board of Supervisors hereby approves the inclusion of those benefit plans qualifying under the employee cafeteria plan as provided and regulated under Section 125 of Title 26 of the United States Code <u>as well as the medical care plans</u> ((and as)) adopted by the Health Service Board and approved by the Board of Supervisors annually under <u>Section</u>

<u>A8.422 of the Charter and Administrative Code Section 16.157 and which medical plans are</u>
