Be it ordained by the People of the City and County of San Francisco:

Section 1. The City Attorney is hereby authorized to settle with plaintiff San Mateo County Transit District in the eminent domain action entitled "*San Mateo County Transit District v. City and County of San Francisco, et al.*," filed in San Mateo County Superior Court No. 406-647 on July 28, 1998, in which SamTrans has condemned a portion of the City's water pipeline, whereby SamTrans relocates the City's water pipeline at no cost to the City, the City conveys its interest in the former easement to SamTrans, and SamTrans conveys a new easement to the City for the relocated pipeline.


