Be it ordained by the People of the City and County of San Francisco:

Section 1. Findings

The Board of Supervisors hereby finds that 678 Mission Street, Lot 21 in Assessor's Block 3707, the Builders' Exchange Building, merits a change of its designation under Section 1106 of Article 11 of the San Francisco Planning Code, from Category V (Unrated) to Category III (Contributory). This change of designation has been fully approved by Resolution No. 16101 of the Planning Commission, which Resolution is on file with Clerk of the Board of Supervisors under File No. <u>010668</u> and which Resolution is incorporated herein and made part hereof as though fully set forth.

Section 2. Amending Appendix C of Article 11 of the San Francisco Planning Code to

add: <u>678 Mission Street</u> 3703 21 Builders' Exchange Building.

(a) Upon issuance of a statement of eligibility pursuant to section 128 of the Planning Code, no alterations shall be made to the exterior of 678 Mission Street which are not in conformity with the Secretary of Interior's Standards For Historic Preservation. If the
