17 Operating Engineers, AFL-CIO by appending a Letter of Agreement concerning the City's
18 2002-2003 budget which provides: (a) for the City to reduce its "pick-up" of the required
19 employee contribution to the retirement system by 2.75% of the employees' compensation
20 effective July 1, 2002 through June 30, 2003; (b) a 1% base wage increase effective close of
21 business June 30, 2003 and; (c) a no layoff commitment in fiscal year 2002-2003 for
22 employees represented by participating employee organizations.


