9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. The San Francisco Administrative Code is hereby amended by adding  
11 Section 10.100-9, to read as follows:

12 **SEC. 10.100-9. ADMINISTRATIVE SERVICES VEHICLE LEASING PROGRAM FUND.**

13 *(a) Establishment of Fund. The Administrative Services Vehicle Leasing Program Fund is*  
14 *established as a category six fund for the purpose of receiving funds work-ordered or transferred to the*  
15 *Department of Administrative Services by City departments for the use, maintenance, and replacement*  
16 *of City-owned general purpose vehicles, in accordance with the City's comprehensive fleet*  
17 *management program and Administrative Code Section 4.10-1.*

18 *(b) Use of the Fund. Money or property received into the fund shall be used exclusively for*  
19 *maintaining and replacing general purpose vehicles and for administering the vehicle leasing program.*

1           (c) Administration of Fund. The Director of Administrative Services shall submit semi-annual  
2 reports to the Mayor and the Board of Supervisors regarding expenditures from the fund, including the  
3 number, type, and cost of vehicles purchased, the capacity of the fund to replace the City's fleet, and  
4 the rates charged to leasing departments.
