9 Section 1. The City Attorney is hereby authorized to settle the action entitled "Teri
10 Smith v. San Francisco Zoo et al., US District Court No. C02-2936 PJH on the terms of
11 conditions specified in that certain Settlement Agreement and Release of All Claims and
12 Memorandum of Understanding on file with the Clerk of the Board (File No. 050571)
13 ("Settlement Agreement"). Under the terms of the Settlement Agreement, the Recreation and
14 Park Department may spend an amount not to exceed \$1,100,000.00 to make certain
15 disability access improvements at the San Francisco Zoo.

16 Section 2. The above-named action was filed in US District Court on June 19, 2002,
17 and the following parties were named in the lawsuit: Plaintiff Teri Smith and Defendants San
18 Francisco Zoo, San Francisco Zoological Society, San Francisco Department of Parks and
19 Recreation, and City of San Francisco.






