12 Be it ordained by the People of the City and County of San Francisco:

13 Section 1. The San Francisco Health Code is hereby amended by adding Section  
14 3204 to read as follows:

15 **SEC. 3204. APPLICATION FOR MEDICAL CANNABIS DISPENSARY PERMIT.**

16 (a) Every applicant for a medical cannabis dispensary permit shall file an application with the  
17 Director upon a form provided by the Director and pay a non-refundable permit application fee of  
18 \$64406691.00 to cover the costs to all City departments of investigating and processing the  
19 application and any applicable surcharges, exclusive of filing fees for appeals before the Board of  
20 Appeals.


21 Section 2. The San Francisco Business and Tax Regulations Code is hereby amended  
22 by adding Section 249.17 to read as follows:

23 **SEC. 249.17. MEDICAL CANNABIS DISPENSARY LICENSE FEE.**


