16 Be it ordained by the People of the City and County of San Francisco:

17 Section 1. Findings. The Board of Supervisors of the City and County of San Francisco  
18 hereby finds and determines that:

19 (a) Under Planning Code Section 302, the Board of Supervisors finds that this  
20 ordinance will serve the public necessity, convenience and welfare for the reasons set forth in  
21 Planning Commission Resolution No. 17410 recommending the approval of this Zoning Map  
22 Amendment, and incorporates such reasons by this reference thereto. A copy of said  
23 resolution is on file with the Clerk of the Board of Supervisors in File No. \_\_\_\_\_.

24 (b) Under Planning Code Section 101.1, the Board of Supervisors finds that this  
25 ordinance is consistent with the Priority Policies of Planning Code Section 101.1(b) of the  
26 Planning Code and with the General Plan as amended in Ordinance No. 246-07 and hereby

1 reaffirms its findings as set forth in said Ordinance. proposed to be amended in companion  
2 legislation and hereby adopts the findings of the Planning Commission, as set forth in  
3 Planning Commission Resolution No.17410, and incorporates said findings by this reference  
4 thereto.

5 (c) In accordance with the actions contemplated herein, this Board adopted  
6 Planning Commission Motion No.17407, concerning findings pursuant to the California  
7 Environmental Quality Act (California Public Resources Code sections 21000 et seq.) and  
8 made other related findings in Ordinance No. 246-07. The Board reaffirms these CEQA  
9 findings as set forth in Ordinance No. 246-07, which are. A copy of said Motion is on file with  
10 the Clerk of the Board of Supervisors in File No. 071158 and is are incorporated by reference  
11 herein. The Board of Supervisors has reviewed Memoranda from the Planning Department  
12 dated February 29, 2008 and March 19, 2008 and, based on those Memoranda, public  
13 testimony, and information in the files of the Board of Supervisor and the Planning  
14 Department, including, but not limited to, the Final EIR, together with all supporting materials,  
15 reports, documents, public correspondence, public testimony, and Memoranda, makes the  
16 following findings: Since adoption of Ordinance No. 246-07 no substantial changes have  
17 occurred in the Project proposed for approval under this Ordinance that will require revisions  
18 in the Final EIR due to the involvement of new significant environmental effects or a  
19 substantial increase in the severity of previously identified significant effects, no substantial  
20 changes have occurred with respect to the circumstances under which the Project proposed  
21 for approval under the Ordinance are undertaken which will require major revisions to the  
22 Final EIR due to the involvement of new environmental effects or a substantial increase in the  
23 severity of effects identified in the Final EIR and no new information of substantial importance  
24 to the Project as proposed for approval in the Ordinance has become available which  
25

1 indicates that (1) the Project will have significant effects not discussed in the Final EIR, (2)  
 2 significant environmental effects will be substantially more severe, (3) mitigation measure or  
 3 alternatives found not feasible which would reduce one or more significant effects have  
 4 become feasible or (4) mitigation measures or alternatives which are considerably different  
 5 from those in the Final EIR would substantially reduce one or more significant effects on the  
 6 environment. Moreover, based on public testimony and information in the files of the Board of  
 7 Supervisor and the Planning Department, including, but not limited to, the Final EIR, together  
 8 with all supporting materials, reports, documents, public correspondence, and Memoranda,  
 9 the Board reiterates its findings in Ordinance No. 246-07 related to the mitigation monitoring  
 10 program and statement of overriding considerations.

11 Section 2. Under Sections 106 and 302(c) of the Planning Code, the following zoning  
 12 amendments to the Zoning Map, duly approved by resolution of the Planning Commission, are  
 13 hereby adopted as an amendment to Zoning Map Sheet 2 as follows:
