14 Grandfather Fred Suhr was a member of the San Francisco Board of Supervisors and Great  
15 Grandfather John Tadich founded the "Tadich Grill" in 1849, San Francisco's oldest

17 WHEREAS, Greg has recently earned a promotion from Captain of the Mission  
18 Station, where he earned the respect and admiration of residents and fellow officers over a  
19 six year period, to Commander of the Special Operations Division; now, therefore, be it
