3 **Resolution designating temporary selling spaces in the Downtown area and at**
4 **Harvey Milk Plaza for street artists certified by the Arts Commission, City and**
5 **County of San Francisco, for the winter holiday season, 2001, beginning on**
6 **November 15, 2001 and ending on January 15, 2002.**

8 WHEREAS, The Street Artists Ordinance adopted by the voters on November 4, 1975,
9 authorizes the Board of Supervisors, by resolution, to designate sales areas where any
10 street artist or craftsperson previously certified may sell art or craft items; and

11 WHEREAS, A survey by the Arts Commission found that in recent years more street
12 artist spaces in the Downtown area had been eliminated due to construction, curb zone
13 changes, newsracks, planter boxes, etc.; and

14 WHEREAS, The holiday season is the street artists' busiest selling period; and

15 WHEREAS, Last year and the previous eighteen years the Board of Supervisors in
16 resolutions approved temporary selling spaces for the street artists for the winter holiday
17 selling season; and

18 WHEREAS, Last year and the previous five years and the year of 1992 the Board of
19 Supervisors approved temporary selling spaces for street artists at Harvey Milk Plaza; and

20 WHEREAS, The Arts Commission, after conducting a public hearing, recommends the
21 renewal of the previous year's temporary sales spaces in the Downtown area; and

22 WHEREAS, The Arts Commission recommends an additional eight temporary spaces
23 in the Downtown area; and

24 WHEREAS, The Arts Commission recommends the renewal of the previous year's
25 temporary sales spaces at Harvey Milk Plaza; now, therefore, be it

1 RESOLVED, That the Board of Supervisors hereby designates the following
2 temporary selling spaces for street artists certified by the Arts Commission, for the
3 winter holiday season of 2001 beginning on November 15, 2001 and ending on
4 January 15, 2002:

5 Spaces:

6 12 – Market Street, south side, 4th to 5th Streets

7 5 – Market Street, north side, Montgomery to Kearny Streets

8 2 – Market Street, north side, Grant to Kearny Streets

9 10 – Market Street, north side, Battery to Sansome Streets

10 5 – Stockton Street, west side, Post to Sutter Streets

11 1 – Stockton Street, east side, Post to Sutter Streets

12 7 - Stockton Street, east side, O'Farrell to Geary Streets

13 3 – Stockton Street, east side, Market to O'Farrell Streets

14 2 – Montgomery Street, west side, Post to Sutter Streets

15 2 – Post street, north side, Montgomery to Kearny Streets

16 2 – Post Street, south side, Grant to Kearny Streets

17 5 – California Street, north side, Sansome to Montgomery Streets

18 2 – California Street, south side, Sansome to Montgomery Streets

19 3 – Harvey Milk Plaza (upper level)

20 4 – Harvey Milk Plaza (lower level)

21 and be it

22 FURTHER RESOLVED, That the five (5) temporary spaces on Stockton Street,
23 west side, Post to Sutter Streets, are exempt from the provisions of Police Code
24 Section 2405(c)(8)(1) which prohibits street artists from selling, offering for sale or
25 soliciting offers to purchase on any sidewalk adjacent to a curb which has been

1 designated as a white zone; and be it

2 FURTHER RESOLVED, That the two (2) temporary spaces on Post Street, south
3 side, Grant to Kearny Streets, are exempt from the provision of Police Code Section
4 2405(c)(8)(1); and be it

5 FURTHER RESOLVED, That the one (1) temporary space on Stockton Street,
6 east side, Post to Sutter Streets, is exempt from the provision of Police Code Section
7 2405(c)(8)(1); and be it

8 FURTHER RESOLVED, That one (1) of the five (5) temporary spaces on Stockton
9 Street, west side, Post to Sutter Streets, is exempt from the provision of Police Code
10 Section 2405(c)(6) which prohibits artists from selling, offering for sale or soliciting
11 offers to purchase on any sidewalk within twelve (12) feet from the outer edge of any
12 entrance to any building including, but not limited to, doors, driveways, emergency exits
13 measured in each direction parallel to the building line and thence at a 90-degree angle
14 to the curb; and be it

15 FURTHER RESOLVED, That the two (2) temporary spaces on Post Street, north
16 side, Montgomery to Kearny Streets, are exempt from the provisions of Police Code
17 Section 2405(c)(6) and 2405(c)(8)(3) which prohibits artists from selling, offering
18 for sale or soliciting offers to purchase on any sidewalk adjacent to a curb which has
19 been designated a yellow zone; and be it

20 FURTHER RESOLVED, That the two temporary spaces on Montgomery street, west
21 side, Post to Sutter Streets, are exempt from the provisions of Police Code Section
22 2405(c)(6), 2405(c)(8)(3), and 2405(c)(16) which requires street artists to engage in
23 their activities in such a manner that at all times there shall remain open for the passage
24 of pedestrians a space of at least ten (10) feet in width, as measured on a line
25 perpendicular to the curb line, between the edge of the sidewalk farthest from the curb

1 and the street artists' activities; and be it

2 FURTHER RESOLVED, That two (2) of the three (3) temporary spaces on Stockton
3 Street, east side, Market to O'Farrell Streets, are exempt from the provision of Police
4 Code Section 2405(c)(6); and be it

5 FURTHER RESOLVED, That five (5) of the twelve (12) temporary spaces on Market
6 Street, south side, 4th to 5th Streets, are exempt from the provision of Police Code
7 Section 1405(c)(6); and be it

8 FURTHER RESOLVED, That the four (4) spaces in the lower level of Harvey Milk
9 Plaza are exempt from the provision of Police Code Section 2405(c)(6).


