1 [Contract funds for study of long-term effects of HIV infection.]

3 **Resolution authorizing the San Francisco Department of Public Health (SFDPH) to**
4 **enter retroactively into an agreement in the amount of \$69,799 with Public Health**
5 **Foundation Enterprises Inc. (PHFE), the primary contractor, to fund a study of HIV**
6 **Strain Diversity and Nonprogressors; for the period of July 1, 2001 to June 30, 2002.**

8 WHEREAS, PHFE has received funds from the National Institutes of Allergy and
9 Infectious Disease to provide various services and conduct various studies pertinent to
10 projects focused on HIV/AIDS disease progression; and,

11 WHEREAS, PHFE has requested that the SFDPH enter into a subcontract agreement
12 to participate in this project by providing maintenance of a valuable study cohort of
13 nonprogressors which was developed under the City and County of San Francisco; and,

14 WHEREAS, PHFE has agreed to reimburse the SFDPH in the amount of \$69,799 under
15 the terms of this subcontract; and,

16 WHEREAS, As a condition of receiving the funds PHFE requires the SFDPH to enter
17 into an agreement (The "Agreement"), a copy of which is on file with the Clerk of the Board of
18 Supervisors in File No. 011880, which is hereby declared to be a part of this resolution as if
19 set forth fully herein; and,

20 WHEREAS, The subcontract budget includes provision for indirect costs of \$5,131;
21 now, therefore, be it

22 **RESOLVED, That the SFDPH is hereby authorized to enter retroactively into a**
23 **subcontract agreement in the amount of \$69,799 with PHFE, the primary contractor; and, be it**

24 **FURTHER RESOLVED, That the Director of Health is authorized to enter into the**
25 **Agreement on behalf of the City.**

1 FURTHER RESOLVED, That these positions shall be designated as grant "G" funded
2 positions and the authorization for these positions shall terminate when the grant terminates.




