9 WHEREAS, There is currently no coordinated method for administering services for the
10 homeless population, in particular, accessible information for seeking a shelter bed in the City
11 and County of San Francisco; and,

12 WHEREAS, Encouraging homeless people off the streets and into supportive housing
13 costs taxpayers only slightly more than leaving them to fend for themselves; and

14 WHEREAS, It is incumbent on the City to better coordinate its resources in order to
15 best serve those persons who are ready and willing to access a shelter bed if it is available;
16 now, therefore, be it

17 RESOLVED, That the Board of Supervisors does hereby urge the Department of
18 Human Services to coordinate with the Mayor's Office of Homelessness and the Department
19 of Public Health to develop a weekly shelter report, which details the total number beds, the
20 total number of available beds and the total number of used beds in our shelter system,
21 including, but not limited to, our ~~emerging~~ emergency Winter Shelter Program; and, be it

22 FURTHER RESOLVED, The Board does hereby urge these departments to develop a
23 24-hour service request count detailing the number of shelter requests made, the number of
24 shelter placements, the number of people turned away, the number of persons who refused service and the number of persons
25 placed with relatives and other crisis related categories.


