10 WHEREAS, On November October 29, 2013, Supervisor Wiener introduced legislation  
11 amending the Planning Code to expand the definition of “bona fide eating place” to include a  
12 definition based on food sales per occupant; and making environmental findings, and findings  
13 of consistency with the General Plan, and the eight priority policies of Planning Code, Section  
14 101.1. A copy of said legislation is on file with the Clerk of the Board of Supervisors in File  
15 No. 131064 and is incorporated herein by reference; and

16 WHEREAS, On or about November 12, 2013, the Clerk of the Board of Supervisors  
17 referred the proposed ordinance to the Planning Commission, which currently is reviewing the  
18 proposed ordinance; and

19 WHEREAS, The Planning Commission has 90 days to render its decision on proposed  
20 amendments to the Planning Code that the Board of Supervisors initiates; and

21 WHEREAS, The Board, in accordance with Planning Code Section 306.4(d) may, by  
22 Resolution, extend the prescribed time within which the Planning Commission is to render its  
23 decision on proposed amendments to the Planning Code that the Board of Supervisors
