NOTICE IS HEREBY GIVEN that the City Council of the City of Daly City intends to adjust, as authorized, a benefit assessment imposed for Fiscal Year 2023-2024 on certain real property for the purpose of continuing maintenance and operation of certain services benefiting certain real property, pursuant to the Benefit Assessment Act of 1982, and Resolution No. 90-55, adopted on February 12, 1990.

The real property upon which the assessment is proposed to be levied is described in Exhibit "A" hereto (being all parcels to be assessed within the "Area of Benefit"). The revenue derived from the continued assessment will be used to finance the maintenance and operation of services as outlined in the Linda Vista Engineer's Report 2023-2024 Fiscal Year, on file in the Office of the Daly City City Clerk.

The City Council has, by its originating Resolution No. 90-55, determined that a benefit assessment shall be initially adjusted pursuant to the Act on the real property within the Area of Benefit for the purpose of providing the specified maintenance and operation services. In accordance with Resolution No. 90-55, the City Manager has caused a written report (the "Engineer's Report") to be prepared and filed with the City Clerk, which report contains the following information: (1) a description of the Services; (2) a description of each parcel of real property located within the Area of Benefit; (3) the estimate of the cost of providing the services during Fiscal Year 2023-2024, the aggregate amount to be assessed to Area of Benefit for such year, and the amount of the proposed assessment for each parcel within the Area of Benefit for such year, and (4) the basis and schedule of the assessment.

The Engineer's Report is on file with the City Clerk and is available for inspection on the City's website www.dalycity.org.

NOTICE IS FURTHER GIVEN that Monday, the 22nd day of May 2023, at the hour of 7:00 P.M., in the City Council Chambers, City Hall, 333 90th Street, Daly City, California, is hereby fixed as the time and place when the City Council of the City of Daly City will hear and consider all comments related to the Engineer's Report and to the adjustment of benefit assessments for Fiscal Year 2023-2024 for the purpose of providing the Services. 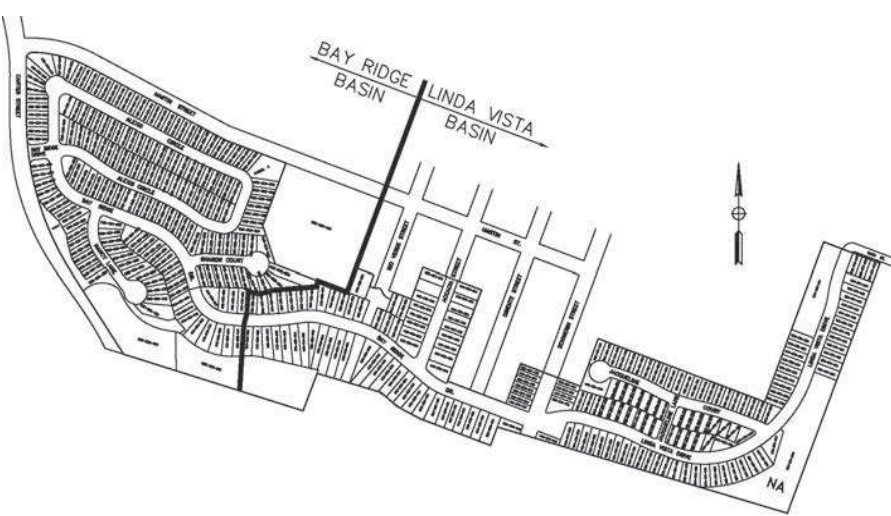
