NOTICE IS HEREBY GIVEN that the City Council of the City of Daly City intends to adjust, as authorized, a benefit assessment imposed for Fiscal Year 2024-2025 on certain real property for the purpose of continuing maintenance and operation of certain services benefiting certain real property, pursuant to the Benefit Assessment Act of 1982, and Resolution No. 90-55, adopted on February 12, 1990.

The real property upon which the assessment is proposed to be levied is described in Exhibit "A" hereto (being all parcels to be assessed within the "Area of Benefit"). In accordance with Resolution No. 90-55, the City Manager has caused a written report (the "Engineer's Report") to be prepared and filed with the City Clerk, which report contains the following information: (1) a description of the Services; (2) a description of each parcel of real property located within the Area of Benefit; (3) the estimate of the cost of providing the services during Fiscal Year 2024-2025, the aggregate amount to be assessed to Area of Benefit for such year, and the amount of the proposed assessment for each parcel within the Area of Benefit for such year, and (4) the basis and schedule of the assessment.

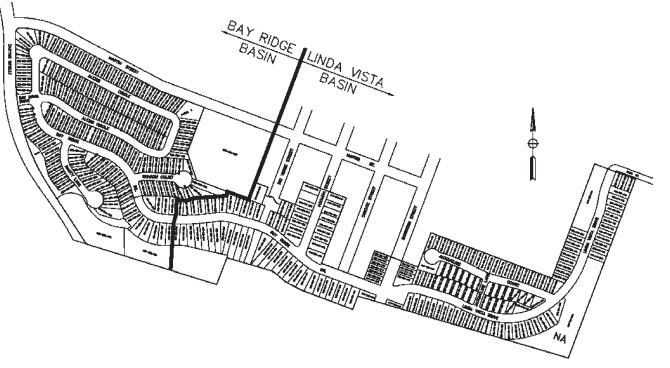
