

1 [Concurring in Proclamation of Local Emergency - Kincade Fire Evacuees]

3 **Motion concurring in the October 27, 2019, proclamation by Mayor London N. Breed**
4 **declaring the existence of a local emergency, in the actions taken to meet the**
5 **emergency of the Kincade Fire in Sonoma County, and the request from State**
6 **authorities that the City shelter evacuees from the Kincade Fire.**

8 WHEREAS, On October 27, 2019, Mayor London N. Breed declared a local emergency
9 to exist in connection with the Kincade Fire in Sonoma County (“the Fire”); on October 25,
10 2019, the Governor declared a state of emergency in Sonoma County due to the Fire; the Fire
11 has now grown to more than 75,000 acres and is minimally contained; the Fire has destroyed
12 more than 120 structures, including homes, and 90,000 structures are under threat from the
13 Fire; authorities in Sonoma County have ordered the evacuation of 185,000 people; and the
14 City has received a request from State authorities to shelter evacuees displaced by the Fire;
15 and

16 WHEREAS, The Mayor does hereby find that the aforesaid conditions of extreme peril
17 justify and require a proclamation of the existence of a local emergency; and

18 WHEREAS, The Mayor has transmitted a copy of that Proclamation Declaring the
19 Existence of a Local Emergency to the Board of Supervisors, and such copy is on file with the
20 Clerk of the Board of Supervisors in File No. 191103; and

21 WHEREAS, The Mayor has directed the head of each department and agency to
22 observe his or her proper relationship in the command structure of the Incident Command
23 System, and be responsive to the orders and requests of the Lead Department designated to
24 exercise supervision over his or her department during the course of this emergency; and

1 WHEREAS, The Governor of the State of California is hereby requested to include the
2 area of the City and County of San Francisco in any emergency declaration by the State, and
3 is further requested to ensure that the City and County of San Francisco is included in any
4 emergency declaration that may be issued by the President of the United States; and

5 WHEREAS, This declaration of a local emergency shall be deemed to continue until it
6 is terminated by the Mayor or the Board of Supervisors; all departments of the City and
7 County of San Francisco are strictly enjoined to cooperate with the requests for material and
8 personnel resources by the City's Incident Command System staff located in the Emergency
9 Operations Center; now, therefore, be it

10 MOVED, That the Board of Supervisors concurs with the Proclamation by the Mayor
11 Declaring the Existence of Local Emergency issued on October 27, 2019, and in the actions
12 taken by the Mayor to meet the emergency.
