WHEREAS. It is the policy of the Board of Supervisors that each program of the City and County of San Francisco be the subject of a performance audit at least once every eight years; and

WHEREAS. The function of regular performance audits is to ensure that City departments and agencies make prudent and efficient use of City resources and also effectively perform the functions assigned to them by the Charter and applicable laws; and

WHEREAS, The Board recently augmented the Budget and Legislative Analyst's audit capacity in order to conduct more proactive oversight of City departments, processes, and practices to identify potential areas of improvement and mitigate the potential for corruption; now, therefore, be it

MOVED. That the Budget and Legislative Analyst is hereby directed to initiate a multipart performance audit in Fiscal Year (FY) 2022-2023 of various City departments' delegated authority for procurement of public works contracts pursuant to Chapter 6 of the Administrative Code including, but not limited to (i) Airport, (ii) Municipal Transportation Agency, (iii) Port, (iv) Public Utilities Commission, and (v) Recreation and Parks; and, be it

FURTHER MOVED, That the Budget and Legislative Analyst is hereby directed to initiate a performance audit in FY2022-2023 of the City's approach to minimize conflicts of interest amongst public officials, staff, and contractors; the audit may include, but not be limited to, a review of statements of economic interests, an assessment of departmental controls, and a survey of other jurisdictions.
