Abigail Laurence Alderson, seat 10, succeeding Maria Luz Torre, term expired, must be nominated by the Health Authority and enrolled, or be the parent or legal guardian of an enrollee, in any of the health insurance or health care coverage programs operated by the Health Authority, for the unexpired portion of a three-year term ending January 15, 2025;

Jian Qing Zhang, seat 2, succeeding themself, term expired, must be employed in the senior management of a hospital not operated by the county or the University of California and who is a nominee of the San Francisco Section of Westbay Hospital Conference or any successor organization, or if no successor organization, a person who shall be nominated by the Hospital Council of Northern and Central California, for the unexpired portion of a three-year term ending January 15, 2026;

Roland Pickens, seat 3, succeeding themself, term expired, must be employed in the senior management of San Francisco General Hospital, for the unexpired portion of a three-year term ending January 15, 2027;

Joseph Woo, seat 7, succeeding themself, term expired, must be a physician, nominated by the San Francisco Medical Society, or any successor organization, for the unexpired portion of a three-year term ending January 15, 2027;

Steven Fugaro, seat 8, succeeding themself, term expired, must be a physician, nominated by the San Francisco Medical Society, or any successor organization, for the unexpired portion of a three-year term ending January 15, 2027;

Norlissa Cooper, seat 9, succeeding themself, term expired, must be nominated by the San Francisco labor Council, or any successor organization, for the unexpired portion of a three-year term ending January 15, 2027;

Juthaporn Chaloeicheep, seat 11, initial appointment, must be a nominee of the Health Authority Beneficiary Advisory Committee, at least one of whom shall, at the time of appointment and during their tenure, be a Medi-Cal beneficiary, for the unexpired portion of a three-year term ending January 15, 2027.
