14 Sascha Bittner, seat 11, succeeding themselves, term expired, must be a consumer
15 between the ages of 18 and 60, authorized to represent organizations that advocate for
16 younger people with disabilities, for a three-year term ending March 1, 2027;

17 Daisy McArthur, seat 12, succeeding themselves, term expired, must be a member
18 representing the bargaining unit of the union that represents In-Home Supportive Services
19 independent providers, for a three-year term ending March 1, 2026;

20 Robin Wilson-Beattle, seat 13, succeeding themselves, term expired, must be a consumer
21 between the ages of 18 and 60, authorized to represent organizations that advocate for
22 younger people with disabilities, for a three-year term ending March 1, 2026.
