13 Be it ordained by the People of the City and County of San Francisco:

14 Section 1. The Board of Supervisors hereby adopts and implements the Memorandum  
15 of Understanding (“MOU”) between the City and County of San Francisco and the Municipal  
16 Executives Association, to be effective July 1, 2022 through June 30, 2024.

17 The MOU so implemented is on file with the Clerk of the Board of Supervisors in Board  
18 File No. 220576.

19 Section 2. The Board of Supervisors hereby authorizes the Department of Human  
20 Resources to make non-substantive ministerial or administrative corrections to the MOU.

21  
22 Section 3. This ordinance shall become effective upon enactment. Enactment occurs  
23 when the Mayor signs the ordinance, the Mayor returns the ordinance unsigned or does not  
24 sign the ordinance within ten days of receiving it, or the Board of Supervisors overrides the  
25 Mayor’s veto of the ordinance.
