14 Be it ordained by the People of the City and County of San Francisco:

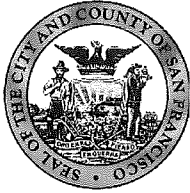
15 Section 1. The Board of Supervisors hereby adopts and implements the Collective  
16 Bargaining Agreement (“CBA”) between the City and County of San Francisco and the  
17 Transport Workers Union of America, Local 250-A, Automotive Service Workers (7410), to be  
18 effective July 1, 2022 through June 30, 2024.

19 The CBA so implemented is on file with the Clerk of the Board of Supervisors in Board  
20 File No. 220586.

21 Section 2. The Board of Supervisors hereby authorizes the Department of Human  
22 Resources to make non-substantive ministerial or administrative corrections to the CBA.

24 Section 3. Effective Date. This ordinance shall become effective upon enactment.


