Section 1. The Board of Supervisors hereby adopts and implements the decision and award of the Arbitration Board under Charter Section A8.590-4, establishing the Collective Bargaining Agreement ("CBA") between the City and County of San Francisco and the San Francisco Sheriffs' Managers and Supervisors Association, to be effective July 1, 2024 through June 30, 2027.

The Arbitration Board decision and award and the CBA so implemented are on file with the Clerk of the Board of Supervisors in Board File No. 240527.

Section 2. The Board of Supervisors hereby authorizes the Department of Human Resources to make non-substantive ministerial or administrative corrections to the CBA.

Section 3. This ordinance shall become effective upon enactment. Enactment occurs when the Mayor signs the ordinance, the Mayor returns the ordinance unsigned or does not sign the ordinance within ten days of receiving it, or the Board of Supervisors overrides the Mayor's veto of the ordinance.
