13 Section 1. The Board of Supervisors hereby adopts and implements the Memorandum
14 of Understanding ("MOU") between the City and County of San Francisco and the San
15 Francisco Building Inspectors' Association, to be effective July 1, 2019 through
16 June 30, 2022.

20 Section 2. The Board of Supervisors hereby authorizes the Department of Human
21 Resources to make non-substantive ministerial or administrative corrections to the MOU.

23 Section 3. Effective Date. This ordinance shall become effective upon enactment.
