

1 [Accept and Expend Grant - Retroactive - The Board of State and Community Corrections -  
2 Proposition 64 Public Health and Safety Grant Program - Amendment to the Annual Salary  
3 Ordinance for FYs 2020-2021 and 2021-2022 - \$1,000,000]

4 **Ordinance retroactively authorizing the Office of Cannabis to accept and expend a**  
5 **grant award in the amount of \$1,000,000 from the Board of State and Community**  
6 **Correction for the Proposition 64 Public Health and Safety Grant Program for a term of**  
7 **May 1, 2021, through October 31, 2024; and amending Ordinance No. 166-20 (Annual**  
8 **Salary Ordinance File No. 200568 for Fiscal Years (FYs) 2020-2021 and 2021-2022) to**  
9 **provide for the addition of one grant funded Class 1823 Senior Administrative Analyst**  
10 **position (FTE 1.0) at the Office of Cannabis for the period of July 1, 2021, through June**  
11 **30, 2022.**

19 Be it ordained by the People of the City and County of San Francisco:

20 Section 1. Findings.

21 (a) In November 2016, California voters approved Proposition 64, the Control,  
22 Regulate and Tax Adult Use of Marijuana Act ("Proposition 64"), which legalized adult use  
23 cannabis in California for individuals 21 years of age and older. AB 1872 (Stats. 2020, Ch.  
24 93) created the Proposition 64 Public Health and Safety Grant Program, administered by the  
25 Board of State and Community Corrections ("BSCC"), to distribute funds paid into the

1 California State and Local Government Law Enforcement Account under Proposition 64 as  
2 grants to local governments.

3 (b) The San Francisco Office of Cannabis (“Office of Cannabis”) operates a local  
4 equity program for commercial cannabis activity, created by Ordinance No. 230-17, approved  
5 December 6, 2017, effective January 5, 2018.

6 (c) In January 2021, the Office of Cannabis submitted an application to BSCC for a  
7 grant from the Proposition 64 Public Health and Safety Grant program to support the Office of  
8 Cannabis’ efforts to address the public health and safety effects of Proposition 64, including  
9 limiting youth exposure to cannabis and supporting regulatory compliance by cannabis  
10 businesses.

11 (d) In April 2021, BSCC awarded the Office of Cannabis a grant of \$1,000,000, for a  
12 grant term of May 1, 2021, to October 31, 2024, to support its efforts to address the public  
13 health and safety effects of Proposition 64 (the “BSCC Grant”).

14  
15 Section 2. Authorization to accept and expend grant funds.

16 (a) The Board of Supervisors hereby authorizes the City Administrator and/or the  
17 Office of Cannabis to accept and expend, on behalf of the City and County of San Francisco,  
18 the BSCC Grant, and for the Deputy City Administrator to sign the BSCC grant agreement  
19 included in BOS File No. 210867 (the “Grant Agreement”), including any amendments thereto.

20 (b) The Board of Supervisors agrees that the funds received under the BSCC Grant  
21 shall not be used to supplant expenditures controlled by this body.

22 (c) The Board of Supervisors, on behalf of the City and County of San Francisco,  
23 agrees to abide by the terms and conditions of the Grant Agreement.

1 (d) The Grant Agreement includes a provision for indirect costs of \$100,000, and  
2 the Board of Supervisors approves inclusion of indirect costs in the Office of Cannabis budget  
3 for expending the BSCC Grant.

5 Section 3. Grant funded positions; Amendment to Fiscal Year 2020-2021 and Fiscal  
6 Year 2021-2022-Annual Salary Ordinance.

7 The hereinafter designated sections and items of Ordinance No. 166-20 (Annual Salary  
8 Ordinance File No. 200568 for FY 2020-2021 and FY 2021-2022) are hereby amended so  
9 that the same shall read as follows:
