2 Terminal 1 Retail Concession Lease 8 - Termination Fee \$75,000]

3 **Resolution approving Lease Termination Agreement for the Harvey Milk Terminal 1**  
4 **Retail Concession Lease 8 at San Francisco International Airport, Lease No. 20-0045,**  
5 **between Minute Suites Travelers Retreat SFO, LLC, as tenant, and the City and**  
6 **County of San Francisco, acting by and through its Airport Commission.**

8 WHEREAS, On March 17, 2020, by Resolution No. 20-0045, the Airport Commission  
9 (Commission) awarded the Airport Harvey Milk Terminal 1 Retail Concession Lease 8 –  
10 (Lease) to Minute Suites Travelers Retreat SFO, LLC (Tenant); and

11 WHEREAS, By Resolution No. 525-20 adopted on November 20, 2020, this Board of  
12 Supervisors approved the Lease, a copy of which is on file with the Clerk of the Board in File  
13 No. 201082; and

14 WHEREAS, Tenant never commenced construction or opened for business as a result  
15 of the COVID-19 pandemic; and

16 WHEREAS, Tenant has requested to terminate the Lease, citing significantly increased  
17 costs since the Lease was executed and a decrease in sales nationwide for spa services in  
18 airports due to a significantly diminished business climate for spa services in airports resulting  
19 from the pandemic; and

20 WHEREAS, The Airport is agreeable to such termination pursuant to a Lease  
21 Termination Agreement that provides for Tenant to pay a termination fee in the amount of  
22 \$75,000 which is equal to one half of the Minimum Annual Guarantee rent payable under the  
23 Lease (Lease Termination Agreement); and

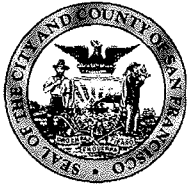
24 WHEREAS, Airport staff believes this is a fair and reasonable amount that will  
25 compensate the Airport for the loss of revenue it will sustain as a result of such termination,

1 and is confident that a new tenant with a more profitable concept can be identified through a  
2 competitive process; and

3 WHEREAS, On August 20, 2024, by Resolution No. 24-0189, the Commission  
4 approved the Lease Termination Agreement; now, therefore, be it

5 RESOLVED, That this Board of Supervisors hereby approves the Lease Termination  
6 Agreement for the Harvey Milk Terminal 1 Retail Concession Lease 8, Lease No. 20-0045  
7 with Minute Suites Travelers Retreat SFO, LLC, a copy of which is on file with the Clerk of  
8 the Board of Supervisors in File No. 240923; and, be it

9 FURTHER RESOLVED, That within 30 days of the Lease Termination Agreement being  
10 fully-executed by all parties, the Airport Commission shall provide the final lease termination  
11 agreement to the Clerk of the Board for inclusion into the official file.
