WHEREAS, There were a total of 40 fire units, 7 medic units, and 130 firefighters on scene, many who battled the fire for hours until it was brought under control in the early morning; and

WHEREAS, No members of the public were injured, however, unfortunately one firefighter suffered an injury while on scene; and

WHEREAS, As a result of this devastating fire, tragically eight individuals were displaced from nearby buildings and were given aid by the American Red Cross, Salvation Army, and the City; additionally, seven small businesses also suffered damage; now, therefore, be it

RESOLVED, That the Board of Supervisors for the City and County of San Francisco commends the brave members of the Fire Department who responded to this fire, helped save lives, and protect the public; and, be it

FURTHER RESOLVED, That the Board of Supervisors for the City and County of San Francisco will continue to support efforts to assist the tenants and small businesses impacted by this fire.
