

1 [Accept and Expend Grant - Retroactive - California Department of Social Services -
2 Commercial Sexual Exploitation of Children Placement and Services Program - \$7,000,000]

3 **Resolution retroactively authorizing the Department on the Status of Women to accept**
4 **and expend a grant from the California Department of Social Services for the**
5 **Commercial Sexual Exploitation of Children Placement and Services Program in the**
6 **amount of \$7,000,000 for a three-year grant period from January 1, 2023, through**
7 **December 31, 2025.**

9 WHEREAS, On October 20, 2022, the California Department of Social Services sent
10 the Department on the Status of Women (“Department”) an intent-to-award letter for funding in
11 the 2022-2023 State Budget approved by the Governor’s Office on June 27, 2022, in the
12 amount of \$7,000,000 for the Commercial Sexual Exploitation of Children Placement and
13 Services Program for the period of January 1, 2023, to December 31, 2025; and

14 WHEREAS, Funding from the California Department of Social Services will enable the
15 Department on the Status of Women to continue to develop, implement and provide a
16 continuum of placement and services model that will directly benefit youth who are at risk of or
17 experiencing commercial sexual exploitation; and

18 WHEREAS, The Project budget includes indirect costs in the amount of \$81,637 10%
19 of the Department’s total direct cost of \$816,374.39; now, therefore, be it

20 RESOLVED, That the Department on the Status of Women is retroactively authorized
21 to accept and expend up to \$7,000,000 awarded by the California Department of Social
22 Services to support the Commercial Sexual Exploitation of Children Placement and Services
23 Program.


