3 **Resolution authorizing the Office of Contract Administration to execute**  
4 **Amendment No. 2 to Contract 1000013880 between the City and County of San**  
5 **Francisco and Golden Gate Petroleum, for the purchase of renewable diesel fuel**  
6 **for City departments; increasing the contract amount by \$23,000,000 for a total**  
7 **contract amount not to exceed \$68,000,000 and extending the term by two years**  
8 **and two months from March 31, 2022, for a total contract duration of five years of**  
9 **June 1, 2019, through May 31, 2024.**

11 WHEREAS, Charter, Section 9.118(b), requires the Board of Supervisors to  
12 approve by Resolution contracts estimated to cost the City \$10,000,000 or more; and

13 WHEREAS, This Agreement was competitively procured as required by  
14 Administrative Code, Chapter 21.1, through Invitation for Bids #70886, issued on  
15 December 18, 2018, in which City selected Golden Gate Petroleum (Contractor) as the  
16 lowest bidder pursuant to the Invitation for Bids; and

17 WHEREAS, The Office of Contract Administration entered into an as-needed term  
18 contract with Contractor, dated June 01, 2019, to renewable diesel for City departments;  
19 and

20 WHEREAS, Amendment No. 1, dated, March 18, 2020, to the Agreement  
21 modified several contract terms and conditions; and

22 WHEREAS, Amendment No. 2 will increase the total not to exceed contract  
23 amount to \$71,100,000 and extend the contract duration to May 31, 2024; and

1           WHEREAS, The amendment referenced above is on file with the Clerk of the  
2 Board of Supervisors in File No. 220173, which is hereby declared to be part of this  
3 resolution as if set forth fully herein; now, therefore, be it

4           RESOLVED, That the Board of Supervisors, under Charter, Section 9.118(b),  
5 hereby authorizes the Office of Contract Administration to execute Amendment No. 2  
6 to the Contract 1000013880 between the City and County of San Francisco and  
7 Golden Gate Petroleum for the purchase of renewable diesel for City departments;  
8 increasing increase the contract amount by \$23,000,000 for a total contract amount of  
9 \$68,000,000 and by extending the term by two years and two months from March 31,  
10 2022, for a total contract duration of five years of June 1, 2019, through May 31, 2024;  
11 and, be it

12           FURTHER RESOLVED, That within 30 days of the modification being fully  
13 executed by all parties, the Purchaser shall provide the final copy of modification to the  
14 Clerk of the Board for inclusion into the official file.
