4 **Resolution retroactively authorizing the Office of Economic and Workforce**
5 **Development to accept and expend a grant in the amount of \$900,000 from the James**
6 **Irvine Foundation during the grant period of November 7, 2022, through November 7,**

9 WHEREAS, The Administrative Code requires City departments to obtain Board of
10 Supervisors' approval to accept or expend any grant funds (Section 10.170 et seq.); and

11 WHEREAS, The James Irvine Foundation released funding for the continued
12 facilitation of the Northern California Apprentice Network; and

13 WHEREAS, San Francisco's Office of Economic and Workforce Development,
14 proposed sustainability efforts for regional tech apprenticeship coordination in partnership with
15 the Bay Area Video Coalition; and

16 WHEREAS, The James Irvine Foundation awarded San Francisco's Office of
17 Economic and Workforce Development, the Northern California Apprentice Network and
18 apprenticeship growth in Northern California grant; and

19 WHEREAS, The grant does not require an Annual Salary Ordinance amendment; and

20 WHEREAS, The Project budget includes indirect costs in the amount of \$90,000, 10%
21 of the estimated total direct costs now, therefore, be it

22 RESOLVED, That the Board of Supervisors hereby approves the inclusion of indirect
23 costs in the grant budget; and, be it

24 FURTHER RESOLVED, That the Office of Economic and Workforce Development is
25 responsible for oversight of funding from The James Irvine Foundation; and, be it

1 FURTHER RESOLVED, That the Board of Supervisors hereby authorizes the Office of
2 Economic and Workforce Development to accept and expend, on behalf of the City and
3 County of San Francisco, a grant from The James Irvine Foundation, for the Northern
4 California Apprentice Network and apprenticeship growth in Northern California grant in the
5 amount of \$900,000; and, be it

6 FURTHER RESOLVED, That the Director of the Office of Economic and Workforce
7 Development is authorized to enter into the Agreement on behalf of the City.




