11 WHEREAS, The Department of Public Health (DPH) seeks to enter into a  
12 Memorandum of Understanding (MOU) with the San Francisco Public Health Foundation  
13 (Foundation) to establish the roles and responsibilities of each for purposes of fundraising and  
14 capital projects; and

15 WHEREAS, The San Francisco Charter Section 9.118(a) requires contracts entered by  
16 a department having anticipated revenue to the City of \$1,000,000 or more be approved by  
17 the San Francisco Board of Supervisors by Resolution; and

18 WHEREAS, A draft of the Agreement is on file with the Clerk of the Board of  
19 Supervisors in File No. 230673, which is hereby declared to be a part of this Resolution as if  
20 set forth fully herein; now, therefore, be it

21 RESOLVED, That the Board of Supervisors hereby authorizes the Director of Health to  
22 enter into a Memorandum of Understanding with the San Francisco Public Health Foundation  
23 to establish the roles and responsibilities of each for purposes of fundraising and capital  
24 projects and, be it


