9 WHEREAS, Upon completion of a competitive selection process, the Airport
10 Commission adopted Resolution No. 18-0073 on March 20, 2018, awarding the Terminal 2
11 Specialty Retail Concession Lease No. 3 to Canonica New York, LLC; and

12 WHEREAS, The Terminal 2 Specialty Retail Concession Lease No. 3 has a term of
13 seven years to commence following Board approval, and an initial minimum annual guarantee
14 of \$225,000.00; now, therefore, be it

15 RESOLVED, That this Board of Supervisors hereby approves the Terminal 2 Specialty
16 Retail Concession Lease No. 3, a copy of which is on file with the Clerk of the Board of
17 Supervisors in File No. 180599; and, be it

18 FURTHER RESOLVED, That within thirty (30) days of the lease being fully-executed by
19 all parties, the Airport Commission shall provide the final lease to the Clerk of the Board for
20 inclusion into the official file.




