

1 [Accept and Expend Grant - Bay Area Air Quality Management District - Install Level-2  
2 Electric Vehicle Chargers at Six Park Sites - \$619,085]

3 **Resolution authorizing the Recreation and Park Department to accept and expend a**  
4 **grant in the amount of \$619,085 from the Bay Area Air Quality Management District to**  
5 **install level-2 electric vehicle chargers at six park sites, including the Crocker Amazon**  
6 **Maintenance Garage, Louis Sutter Maintenance Yard, Civic Center Garage, Balboa Park**  
7 **Boxer Stadium, Margaret Hayward Maintenance Garage, and McLaren Park Caretakers**  
8 **Cottage, effective upon approval of this Resolution through January 29, 2026.**

10 WHEREAS, The Bay Area Quality Management District (BAAQMD) is a public agency  
11 that oversees policies and adopts regulations for the control of air pollution in the nine  
12 counties of the San Francisco Bay Area; and

13 WHEREAS, BAAQMD aims to create a healthy breathing environment for every Bay  
14 Area resident while protecting and improving public health, air quality, and the global climate;  
15 and

16 WHEREAS, BAAQMD has approved the Recreation and Park Department's (RPD)  
17 grant proposal to install 25 electric vehicle chargers at the following six park sites: Crocker  
18 Amazon Maintenance Garage, Louis Sutter Maintenance Yard, Civic Center Garage, Balboa  
19 Park Boxer Stadium, Margaret Hayward Maintenance Garage, and McLaren Park Caretakers  
20 Cottage; and

21 WHEREAS, The six sites were selected based on operational necessities and their  
22 alignment with BAAQMD's eligibility criteria which includes geographic requirements; and

23 WHEREAS, This grant supports RPD's goal of transitioning to an electric fleet and will  
24 enable to power electric vehicles including carts and mowers; and

1           WHEREAS, The Department proposes to maximize the use of available grant funds on  
2 project expenditures by not including indirect costs in the grant budget; and

3           WHEREAS, On April 18, 2024, the Recreation and Park Commission adopted  
4 Resolution No. 2404-005 recommending that the Board of Supervisors authorize RPD to  
5 accept the Grant; and

6           WHEREAS, The City recognizes the generosity of BAAQMD with sincere appreciation;  
7 now, therefore, be it

8           RESOLVED, That the Board of Supervisors hereby waives inclusion of indirect costs in  
9 the grant budget; and, be it

10          FURTHER RESOLVED, That the Board of Supervisors approves the Grant and  
11 authorizes the Recreation and Park Department General Manager to accept and expend a  
12 grant in the amount of \$619,085 from the Bay Area Air Quality Management District to install  
13 level-2 electric vehicle chargers at six park sites, effective upon approval of this Resolution  
14 through January 29, 2026; and, be it

15          FURTHER RESOLVED, That within 30 days of the Grant Agreement being fully-  
16 executed by all parties, the Recreation and Park Department shall provide the final Grant  
17 Agreement to the Clerk of the Board for inclusion into the official file.


