20 WHEREAS, Californians will be joining together across the state to clear the air on
21 October 5, 2022; and

24 **RESOLVED**, By the San Francisco Board of Supervisors that the first Wednesday of
25 October be declared “Clean Air Day” in the City and County of San Francisco; and, be it
