3 **Resolution determining that the transfer of a Type-48 on-sale general public**  
4 **premises liquor license, converted from a Type-47 on-sale general for bona fide**  
5 **eating place liquor license, to Conary and Murphy LLC, to do business as**  
6 **Murphy's Pub, located at 217 Kearny Street (District 3), will serve the public**  
7 **convenience or necessity of the City and County of San Francisco in accordance**  
8 **with California Business and Professions Code, Section 23958.4.**

10 WHEREAS, Conary and Murphy LLC is seeking the transfer of a Type-48 on-  
11 sale general public premises liquor license, converted from a Type-47 on-sale general  
12 for bona fide eating place liquor license to do business as Murphy's Pub, located at 217  
13 Kearny Street (District 3); and

14 WHEREAS, The Planning Department has verified that the area is properly  
15 zoned and recommends approval; and

16 WHEREAS, The Police Department has filed zero protests and zero letters of  
17 support with the Department of Alcoholic Beverage Control under California Business  
18 and Professions Code, Section 24013, and recommends that the Department of  
19 Alcoholic Beverage Control issue the liquor license without conditions; now, therefore,  
20 be it

21 RESOLVED, That in accordance with California Business and Professions Code,  
22 Section 23958.4, the Board of Supervisors of the City and County of San Francisco  
23 hereby determines that the transfer of a Type-48 on-sale general public premises liquor  
24 license, converted from a Type-47 on-sale general for bona fide eating place liquor

1 license, to Conary and Murphy LLC, to do business as Murphy's Pub, will serve the  
2 public convenience or necessity of the City and County of San Francisco; and, be it

3 FURTHER RESOLVED, That the Board of Supervisors of the City and County of  
4 San Francisco hereby endorses and adopts the recommendations of the Police  
5 Department listed above and recommends that the Department of Alcoholic Beverage  
6 Control issue the license.
