Resolution retroactively authorizing the Office of Contract Administration (OCA) to execute Contract 1000024326 between the City and County of San Francisco and Auction Exchange Inc., dba Bar None Auction for as-needed citywide auction services for disposal of City owned vehicles and heavy equipment for an estimated anticipated revenue amount of \$3,900,000 for a term of five years commencing on October 1, 2024, through September 30, 2029; and authorizes OCA to enter into any amendments or modifications to the Agreement that OCA determines, in consultation with the City Attorney, are necessary to correct clerical and/or administrative errors, as long as those changes are consistent with this Resolution.

WHEREAS, Charter, Section 9.118(a), requires contracts where anticipated revenues exceed \$1,000,000 and subsequent modifications of such contracts to be approved by the Board of Supervisors; and

WHEREAS, City expects to received revenues of approximately \$3,900,000 for the auctioning of City owned assets over a five year period commencing on October 1, 2024, through September 30, 2029; and

WHEREAS, The proposed Contract 1000034294 with Auction Exchange Inc., dba Bar None Auction ("Bar None") was competitively procured through a Request for Proposals issued by the Office of Contract Administration ("OCA") on June 10, 2024 under Sourcing Event 0000009684; and

WHEREAS, Sourcing Event 0000009684 requested Proposals for Auction Services to sell City's obsolete and surplus vehicles and heavy equipment to the highest bidder through monthly and as-needed, multi-seller public auctions; and


WHEREAS, In response to Sourcing Event 0000009684 OCA received three proposals, of which Bar None's proposal was deemed the highest ranked proposal; and

WHEREAS, The fully executed proposed Agreement is contained in File No. 240922, and is conditioned upon approval of this Resolution; now, therefore, be it

RESOLVED, That the Board of Supervisors hereby approves retroactively the Agreement contained in File No. 240922; and be it

FURTHER RESOLVED, That the Board of Supervisors authorizes OCA to enter into any amendments or modifications to the Agreement that OCA determines, in consultation with the City Attorney, are necessary to correct clerical and/or administrative errors, as long as those changes are consistent with this Resolution; and be it

FURTHER RESOLVED, That within 30 days of the Agreement being fully executed by all parties, OCA shall submit to the Clerk of the Board of Supervisors a completely executed copy for inclusion in File No. 240922; this requirement and obligation resides with the Department, and is for purposes of having a complete file only, and in no manner affects the validity of approved Agreement.
