

1 [Professional Services Agreement - Consor PMCM, Inc. - Construction Management Staff  
2 Augmentation Services for New City Distribution Division Campus at 2000 Marin Street - Not  
3 to Exceed \$10,720,500]

4 **Resolution approving and authorizing the General Manager of the San Francisco Public**  
5 **Utilities Commission (SFPUC) to execute Professional Services Agreement, Contract**  
6 **No. PRO.0239, New City Distribution Division Campus at 2000 Marin Construction**  
7 **Management Staff Augmentation Services, with Consor PMCM, Inc., to supplement the**  
8 **SFPUC’s Construction Management Bureau staff in overseeing the construction of the**  
9 **new City Distribution Division Campus at 2000 Marin project, for an amount not to**  
10 **exceed \$10,720,500 and with a term duration of four years and three months, from**  
11 **February 2025, through April 2029, pursuant to Charter, Section 9.118.**

13 WHEREAS, The San Francisco Public Utilities Commission (SFPUC) City Distribution  
14 Division (CDD) is responsible for the City’s water system, operating and maintaining its  
15 reservoirs, pump stations, and approximately 1,250 miles of water pipes, managing the City’s  
16 water meter program, and maintaining CDD facilities, equipment, and fleet of vehicles; and

17 WHEREAS, The current CDD campus, located at 1990 Newcomb Avenue, has served  
18 as CDD’s main facility for almost six decades; and

19 WHEREAS, Due to significant growth of service demands and challenges with  
20 maintaining operations at a facility that has exceeded its useful life, SFPUC has an acute  
21 need for the development of new facilities to alleviate departmental overcrowding, address  
22 building code and safety issues, eliminate inefficiencies, and accommodate the CDD’s current  
23 and future operational needs; and

1           WHEREAS, SFPUC will construct the new facilities at 2000 Marin Street in San  
2 Francisco on an approximately eight-acre property located off Evans Avenue with frontages  
3 on Marin Street and Cesar Chavez Street; and

4           WHEREAS, On June 28, 2022, by Resolution No. 22-0125, the SFPUC awarded  
5 Contract No. WD-2897R to Clark Construction Group to provide construction services for the  
6 New CDD Campus at 2000 Marin project (the Project); and

7           WHEREAS, On July 29, 2024, the Planning Department approved the Final Mitigated  
8 Negative Declaration for the Project (Case Number 2022-000702ENV); and

9           WHEREAS, On August 13, 2024, by Resolution No. 24-0176, the SFPUC adopted the  
10 Final Mitigated Negative Declaration, approved the Project and adopted findings (California  
11 Environmental Quality Act [CEQA] Findings) and a Mitigation Monitoring and Reporting  
12 Program required by the CEQA, and work under this contract is within the scope of the Project  
13 authorized under the Final Mitigated Negative Declaration; and

14           WHEREAS, The SFPUC requires the services of a qualified construction management  
15 firm to supplement SFPUC Construction Management Bureau staff to monitor project  
16 schedule, budget, and scope and to provide quality assurance construction inspection; and

17           WHEREAS, The estimated cost of services is for an amount not to exceed  
18 \$10,720,500; and

19           WHEREAS, On April 17, 2024, the SFPUC advertised a Request for Proposals for  
20 Contract No. PRO.0239, for construction management staff augmentation services to monitor  
21 Project schedule, budget, and scope and to provide quality assurance construction inspection;  
22 and

23           WHEREAS, The SFPUC and Contract Monitoring Division (CMD), upon review of the  
24 proposal scores, determined that Consor PMCM, Inc., was the highest-ranked firm based on  
25 the established scoring criteria; and

1           WHEREAS, The Contract Monitoring Division (CMD) established a subconsulting  
2 requirement of 20% Local Business Enterprise (LBE) participation for this contract and Consor  
3 PMCM, Inc., committed to 50% LBE subconsulting participation; and

4           WHEREAS, Funds for the agreement are available from the Water Enterprise Capital  
5 Improvement Program, Project No. 10037249, New CDD Campus at 2000 Marin Project; and

6           WHEREAS, On September 24, 2024, by Resolution No. 24-0209, the SFPUC  
7 approved the Professional Services Agreement, Contract No. PRO.0239, New City  
8 Distribution Division (CDD) Campus at 2000 Marin Construction Management Staff  
9 Augmentation Services, with Consor PMCM, Inc., to supplement the SFPUC's Construction  
10 Management Bureau staff in overseeing the construction of the Project, for an amount not to  
11 exceed \$10,720,500 and with a term duration of four years and three months, from February  
12 2025, through April 2029; and

13           WHEREAS, Charter, Section 9.118(b) requires Board of Supervisors' approval by  
14 Resolution of any contract which, when entered into, extends over 10 years, and of any  
15 contract which, when entered into, costs the City \$10,000,000 or more; now, therefore, be it

16           RESOLVED, That this Board of Supervisors hereby approves and authorizes the  
17 General Manager of the San Francisco Public Utilities Commission (SFPUC) to execute  
18 Professional Services Agreement No. PRO.0239, New City Distribution Division (CDD)  
19 Campus at 2000 Marin Construction Management Staff Augmentation Services, with Consor  
20 PMCM, Inc., to supplement the SFPUC's Construction Management Bureau staff in  
21 overseeing the construction of the new CDD Campus at 2000 Marin Project, for an amount  
22 not to exceed \$10,720,500 and with a term duration of four years and three months, from  
23 February 2025 through April 2029; and, be it


