3 **Resolution retroactively authorizing the Department of Public Health to accept and**  
4 **expend an in-kind gift of COVID-19 test kits in the total amount of \$1,372,318.27 from**  
5 **California Department of Public Health, in support of the Department of Public Health**  
6 **clinic patients and staff.**

8 WHEREAS, The California Department of Public Health (CDPH) has agreed to donate  
9 to the Department of Public Health (DPH) an in-kind gift of COVID-19 Test Kits (COVID)  
10 valued in the total amount of \$1,372,318.27 in support of patients and clinical staff of the  
11 Department of Public Health; and

12 WHEREAS, CDPH had gifted the test kits on June 19, 2024, and the test kits was  
13 delivered and installed for DPH's use on June 19, 2024; and

14 WHEREAS, The accept and expend was not done timely; and

15 WHEREAS, Annual reporting to the Board of Supervisors was not made per  
16 Administrative Code, Section 10.100-305; now, therefore, be it

17 RESOLVED, That the Board of Supervisors approves the in-kind gift, and authorizes  
18 DPH to accept and expend an in-kind gift of the COVID valued in the total amount of  
19 \$1,372,318.27 donated by CDPH; and, be it

20 FURTHER RESOLVED, That the proceeds of the in-kind gift by CDPH will be accepted  
21 and expended consistent with the Administrative Code sections governing the acceptance of  
22 gifts to the City and County of San Francisco, including the Administrative Code, Section  
23 10.100-201; and, be it

24 FURTHER RESOLVED, That the Board of Supervisors extends its gratitude to CDPH  
25 for the generous in-kind gift to the City and County of San Francisco in support of DPH.

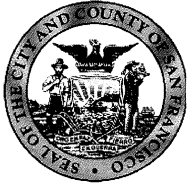
