

1 [Contract - Recology San Francisco - Refuse Collection and Disposal Services - Not to
2 Exceed \$119,000,000]

3 **Resolution approving and authorizing the Office of Contract Administration (“OCA”) to**
4 **enter into Contract 1000034862 between City and County of San Francisco, and Sunset**
5 **Scavenger Company d/b/a Recology Sunset Scavenger, Golden Gate Disposal &**
6 **Recycling Company d/b/a Recology Golden Gate, and Recology San Francisco**
7 **(collectively “Recology”) for the provision of refuse collection and disposal services at**
8 **City facilities, for an initial term of seven years, commencing on January 1, 2025,**
9 **through December 31, 2031, with an option to extend for three additional years through**
10 **December 31, 2034, for a total contract duration of 10 years, and with a total contract**
11 **not to exceed amount of \$119,000,000 for the full 10-year duration; and to authorize**
12 **OCA to make necessary, non-material changes to the Contract prior to its final**
13 **execution by all parties that do not materially increase the obligations or liabilities to**
14 **the City and are necessary or advisable to effectuate the purposes of the Contract.**

16 WHEREAS, On June 30, 2022, the Office of Contract Administration (OCA) issued a
17 Request for Proposals (“RFP”) under Sourcing Event 0000006945, for the collection and
18 disposal of refuse generated at City facilities; and

19 WHEREAS, OCA issued a conditional Notice of Intent to Award the contract to the
20 highest-ranked proposer to the solicitation in January 2023; and

21 WHEREAS, The highest-ranked proposer withdrew its proposal in March 2024, prior to
22 final approval and execution of the new contract, and OCA thereby terminated negotiations
23 with this proposer and commenced negotiations with the second-highest ranked proposer,
24 Recology; and

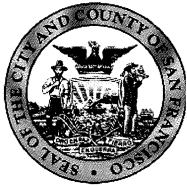
1 WHEREAS, Charter, Section 9.118(b), requires Board of Supervisors' approval by
2 Resolution of any contract which, when entered into, extends over 10 years, and of any
3 contract which, when entered into, costs the City \$10,000,000 or more; and

4 WHEREAS, The proposed Contract contained in File No. 241142, is substantially in
5 final form, with all material terms and conditions included, and only remains to be executed by
6 the parties upon approval of this Resolution; now, therefore, be it

7 RESOLVED, That the Board of Supervisors hereby approves the Contract in
8 substantially the form contained in File No. 241142; and, be it

9 FURTHER RESOLVED, That the Board of Supervisors authorizes OCA to make any
10 modifications to the Contract, prior to its final execution by all parties, that OCA determines, in
11 consultation with the City Attorney, are consistent with this Resolution, in the best interest of
12 the City, do not materially increase the obligations or liabilities of the City, are necessary or
13 advisable to effectuate the purposes of the Contract, and are in compliance with all applicable
14 laws, including City's Charter; and, be it

15 FURTHER RESOLVED, That within 30 days of the Contract being fully executed by all
16 parties, OCA shall submit to the Clerk of the Board of Supervisors a completely executed
17 copy for inclusion in File No. 241142; this requirement and obligation resides with the
18 Department, and is for purposes of having a complete file only, and in no manner affects the
19 validity of approved Contract.
